[Policy Priorities of the Bay Area Latino Health Summit]

RESOLUTION URGING THE SAN FRANCISCO BOARD OF SUPERVISORS TO CONSIDER THE POLICY PRIORITES ARISING OUT OF THE FIRST ANNUAL BAY AREA LATINO HEALTH SUMMIT AND TO INTEGRATE THESE PRIORITIES WHERE APPLICABLE INTO THE CITY'S HEALTH CARE DELIVERY SYSTEM.

WHEREAS, The first annual Bay Area Latino Health Summit was held on December 6, 2000 at the California State Building and consisted of health professionals, advocates and service providers; and,

WHEREAS, The concentration of this summit focused on five areas: physical health, behavioral health, housing, cultural competency and access to health care; and,

WHEREAS, HIV/AIDS, diabetes, cancer and diabetes were identified as important areas within physical health specifically because of the disparities in education and treatment that exist between Latinos and the general population in the level of care; and,

WHEREAS, It is essential to strengthen the safety net and increase the level of community clinic providers and public service providers within each Bay Area county so as to maximize the amount of health care providers and ensure services for prevention and early diagnosis for physical health issues that disproportionately affect Latinos; and,

WHEREAS, Mental health, domestic violence/family injustice and substance use were areas of behavioral health that were the focus of the summit; and,

SUPERVISOR BECERRIL, BIERMAN BOARD OF SUPERVISORS WHEREAS, There was a call to develop new models for service delivery and case management that do not stigmatize the individual, is family-focused, and is integrated, such as partnerships between schools, community clinics, private health care plans, local public agencies, housing authorities and law enforcement agencies; and, WHEREAS, It is critical to develop a directory of Latino

behavioral health providers and services that address the language, immigration and culturally-appropriate needs of the Latino community and that includes community education and outreach components to get critical information into the hands of the community as well as service providers; and,

WHEREAS, Local officials should conduct an audit of the current housing stock within the Bay Area in order to ascertain the level of unsafe, overcrowded, and dangerous living conditions in order to improve the housing situation and further to develop stable housing that meets the needs of special populations such as immigrant populations, the homeless, and those with mental and physical health issues such as HIV/AIDS; and,

WHEREAS, Latinos make up the largest group of uninsured people throughout the state, with more than half of all Latinos being chronically uninsured and, although the majority of Latinos are employed, many do not receive employer-sponsored insurance as they work in seasonal, part time or low wage jobs; and,

WHEREAS, The Bay Area should provide universal health care coverage through a seamless system of delivery whereby all people

will be eligible through a single point of entry process and increase community health education in the Latino community by developing a community health worker (*promotor/promotora*) program that addresses the specific cultural and linguistic needs of the Latino community; now, so therefore be,

RESOLVED, That the San Francisco Board of Supervisors is urged to consider the policy priorities of the Bay Area Health Summit, principal among them addressing physical health, behavioral health, housing, cultural competency, access to health care needs of the Latino community and to integrate these priorities where applicable into the City's health care delivery system.
