3 **Resolution urging the Golden Gate National Recreation Area to delay taking action to**  
4 **ban off-leash dogs at Crissy Field and other GGNRA properties until after thoroughly**  
5 **studying the affect that such a ban would have on the City of San Francisco and**  
6 **particularly on neighborhood parks.**

8 WHEREAS, The San Francisco Recreation and Park Department's Off-leash Dogs  
9 Task Force, composed of various stakeholders such as dog lovers, parents, and  
10 environmentalists have been working to produce and seek final approval for its  
11 recommendations of locations to allow off-leash dogs in a maximum of 17 locations; and,

12 WHEREAS, Approximately 150,000 households in San Francisco own dogs that  
13 require regular exercise; and,

14 WHEREAS, San Francisco dogs have traditionally enjoyed access to various  
15 properties under the present oversight of GGNRA, such as Crissy Field; and,

16 WHEREAS, In 1979, the GGNRA instituted a Pet Policy, allowing access to these  
17 properties; and,

18 WHEREAS, On January 23, 2001, the Golden Gate National Recreation Area's  
19 Citizen's Advisory Committee is poised to revoke this policy; now, therefore, be it

20 RESOLVED, That the San Francisco Board of Supervisors does hereby urge the  
21 Golden Gate National Recreation Area to delay taking action to ban off-leash dogs at Crissy  
22 Field and other GGNRA properties until after thoroughly studying the affect that such a ban  
23 would have on the City of San Francisco and particularly on neighborhood parks; and, be it

24 FURTHER RESOLVED, That copies of this legislation be sent to the Golden Gate  
25 National Recreation Area and to the San Francisco Recreation and Park Department




