3 **Resolution approving the contract between the City and County of San Francisco and**
4 **the United States, through the Department of Energy Western Area Power**

5 **Administration, for the delivery of low cost electric power for use at Treasure Island on**
6 **file with the Clerk of the Board of Supervisors in File No. 002191; and approving**

7 **indemnifying and holding harmless the United States against claims arising from the**
8 **activities of the City under the contract; and waiving requirement of Section 21.35 of**

9 **the San Francisco Administrative Code that every contract contain a statement**
10 **regarding liability of claimants for submitting false claims; and waiving requirement of**

11 **section 21.19 of the San Francisco administrative code that every contract contain a**
12 **statement regarding guaranteed maximum costs.**

14 WHEREAS, The City is currently providing operations and maintenance services at
15 Treasure Island and Yerba Buena Island (TI/YBI) under a multi-year Cooperative Agreement
16 with the Navy; and

17 WHEREAS, The City is the local reuse authority for Naval Station Treasure Island
18 under the Federal Base Closure and Realignment Act (BRAC); and,

19 WHEREAS, The San Francisco Public Utilities Commission is providing the utilities
20 portion of these operations and maintenance services to TI/YBI on behalf of the City; and,

21 WHEREAS, The Western Area Power Administration (WAPA), makes available for
22 authorized uses low-cost Federal National Defense Authorization Act (NDA Act) electric
23 power; and,

24 WHEREAS, The City has been able to obtain an allocation of NDA Act power for the
25 purpose of providing electric service and facilitating economic development on TI/YBI; and,

1 WHEREAS, The City's allocation of NDA Act power for TI/YBI is contingent upon
2 executing a power purchase agreement with WAPA; and,

3 WHEREAS, Funds for the purchase of power are available in the TI/YBI Project
4 budget; and,

5 WHEREAS, The term of the contract is from January 1, 2005 to midnight of
6 December 31, 2024; and,

7 WHEREAS, The Board of Supervisors has previously approved a contract between
8 the City and County of San Francisco and the Western Area Power Administration for the
9 delivery of low cost electric power for use at Treasure Island pursuant to Ordinance No. 348-
10 98; and,

11 WHEREAS, The San Francisco Public Utilities Commission approved the Contract for
12 Electric Service on November 14, 2000. The Contract is a standard form used by the United
13 States for purchases of WAPA power. Indemnification of the United States is a required
14 element of the contract. It would be impossible to modify the Contract to include the
15 statements required by San Francisco Administrative Code Sections 21.35 and 21.19.; and,


16 WHEREAS, The General Manager of the Public Utilities Commission is hereby
17 authorized to execute the Contract for Electric Service with WAPA. A copy of this contract is
18 on file with the Clerk of the Board of Supervisors in File No. 002191 : now, therefore, be it

19 RESOLVED, That the Board of Supervisors hereby waives the requirement of San
20 Francisco Administrative Code Section 21.35 that every contract include a statement
21 regarding liability of claimants for submitting false claims to the City; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors hereby waives the
23 requirement of San Francisco Administrative Code Section 21.19 that every contract include a
24 statement regarding guaranteed maximum costs.




