3 **Resolution urging Governor Gray Davis to appoint a director to the state's Office of**
4 **Ratepayer Advocates .**

6 WHEREAS, The California Public Utilities Act Section 309.5 calls for the Public Utilities
7 Commission Ratepayer Advocate to represent public utility customers in commission
8 proceedings; and

9 WHEREAS, The director of the Office of Ratepayer Advocates shall be appointed by
10 and serve at the pleasure of the Governor, subject to confirmation by the Senate; and,

11 WHEREAS, The goal of the of the Office of Ratepayer Advocates shall be to obtain the
12 lowest possible rate for service consistent with reliable and safe service levels; and,

13 WHEREAS, The California Public Utilities Commission approved a temporary rate
14 increase of 7 to 15 percent to state energy consumers; and,

15 WHEREAS, Due to Pacific Gas and Electric's poor credit rating, California has set
16 aside \$400 million to buy power on a temporary basis; and,

17 WHEREAS, There is currently a proposal to issue revenue bonds to bailout Pacific
18 Gas and Electric's debt; and,

19 WHEREAS, Stage 3 alerts, which happen when energy reserves fall below 1.5 percent
20 of available capacity, have put California energy consumers under continual threat of rolling
21 blackouts; and,

22 WHEREAS, On January 27, The state endured its 11th consecutive day under a Stage
23 3 electrical emergency; and,

24 WHEREAS, The Governor, Gray Davis, has not appointed a director to the state's
25 Office of Ratepayer Advocates; now, therefore, be it
