

1 RESOLUTION ADOPTING FINAL NEGATIVE DECLARATION, FINDING AND DETERMINING
2 THAT THE JOBS-HOUSING LINKAGE ORDINANCE WILL HAVE NO SIGNIFICANT IMPACT
3 ON THE ENVIRONMENT, AND ADOPTING AND INCORPORATING FINDINGS OF FINAL
4 NEGATIVE DECLARATION.

5 WHEREAS, On April 3, 1999, amended April 26, 1999, the Planning Department issued for
6 public review, a preliminary negative declaration, [Case #1999.178E] for the Jobs-Housing Linkage
7 Ordinance; and

8 WHEREAS, On April 27, 1999, the negative declaration was finalized by the Planning
9 Department; and

10 WHEREAS, On December 6, 2000, the Environmental Review Officer concluded that changes
11 to the proposed ordinance do not change the conclusions of the Final Negative Declaration and that no
12 supplemental environmental review is required; and

13 WHEREAS, This Board of Supervisors conducted a public hearing on the matter of adoption
14 of the final negative declaration prior to consideration of the Jobs-Housing Linkage Ordinance; now
15 there, be it

16 RESOLVED, That this Board of Supervisors has considered and reviewed the final negative
17 declaration and adopts said final negative declaration; and be it

18 FURTHER RESOLVED, That this Board of Supervisors hereby finds and determines that
19 there is no substantial evidence that the Jobs-Housing Linkage Ordinance will have a significant effect
20 on the environment and that the negative declaration reflects the lead agency's independent judgment
21 and analysis; and be it

22 FURTHER RESOLVED, That this Board of Supervisors adopts and incorporates herein by
23 reference thereto the findings of the final negative declaration, [Case #1999.178E], issued by the
24 Planning Department, a copy of which is on file with the Clerk of the Board of Supervisors.
