2 AUTHORIZING THE DIRECTOR OF THE DEPARTMENT OF PUBLIC WORKS TO ACCEPT
3 AND EXPEND A GRANT IN THE AMOUNT OF \$7,630,000 IN REGIONAL
4 TRANSPORTATION IMPROVEMENT PROGRAM FUNDS FOR VARIOUS TRANSPORTATION
5 CAPITAL PROJECTS.

7 WHEREAS, S.B. 45 (Chapter 622, Statutes 1997) substantially
8 revised the process for estimating the amount of state and federal
9 funds available for transportation projects in the state for
10 appropriating and allocating the available funds to these projects;
11 and,

12 WHEREAS, As part of that new process, the Metropolitan
13 Transportation Commission (MTC) is responsible for programming
14 projects eligible for Regional Transportation Improvement Program
15 (RTIP) funds, pursuant to Government Code Section 14527(b), for
16 inclusion in the Regional Transportation Improvement Program, and
17 submission to the California Transportation Commission, for inclusion
18 in the State Transportation Improvement Program; and

19 WHEREAS, MTC has requested eligible transportation project
20 sponsors to submit applications nominating projects to be programmed
21 for RTIP funds in the 2000 Regional Transportation Improvement
22 Program, and

23 WHEREAS, The San Francisco County Transportation Authority,
24 acting as Congestion Management Agency, has recommended the
25 programming of a total of \$7,630,000 for the Department of Public


4 WHEREAS, The State of California reimburses for indirect

10 RTIP, now, therefore be it


11 RESOLVED, That the Board of Supervisors does hereby authorize






