RESOLUTION NO. 181-01

1 [Controller's Audit on Marina Yacht Harbor]

2 URGING THE RECREATION AND PARK DEPARTMENT TO IMPLEMENT, WITH ALL DUE  
3 HASTE, THE RECOMMENDATIONS STEMMING FROM THE CONTROLLER'S 2000 SAN  
4 FRANCISCO MARINA SMALL CRAFT HARBOR REPORT.

5 WHEREAS, Dated June 2, 2000, the Controller's Office produced an audit report on the Marina  
6 Small Craft Harbor; and,

7 WHEREAS, The results of this audit was heard in Audit and Government Efficiency Committee  
8 on August 1, 2000 during a public hearing; and,

9 WHEREAS, This audit report recommended a variety of actions be taken so that the harbor may  
10 provide a higher level of service in a more efficient manner; and,

11 WHEREAS, Among the Controller's recommendations included the following:

- 12 1. The Department should completely renovate the Harbor because the facilities are unsafe and  
13 rundown,
- 14 2. The Department and Commission should reexamine and revise certain harbor rules such as  
15 berth transferability, subletting, live-aboards, and regular boat use requirements,
- 16 3. The Department should consider increasing the Harbor's revenues by, among other things,  
17 raising berth fees after renovation, renegotiating a more equitable rent with the St. Francis  
18 Yacht Club, and tightening collection procedures on deposits of cash collections, and,
- 19 4. The Department should develop mission statement goals, objectives, performance measures,  
20 policies and procedures for all functions; and,

21 WHEREAS, The Board of Supervisors recognizes that any public-private partnership or  
22 privatization of operations at the Marina Small Craft Harbor is the least preferable option and may be  
23 injurious to the City and County of San Francisco; and,

24 WHEREAS, On July 20<sup>th</sup>, the Recreation and Park Commission had an opportunity to review  
25 the Controller's Audit; now, therefore, be it

1 RESOLVED, That the San Francisco Board of Supervisors does hereby urge the Recreation and  
2 Park Department to implement, with all due haste, the recommendations stemming from the  
3 Controller's 2000 San Francisco Marina Small Craft Harbor report; and, be it

4 FURTHER RESOLVED, That the San Francisco Board of Supervisors does hereby ask copies  
5 of this resolution to be transmitted to the Recreation and Park Department and to the Recreation and  
6 Park Commission.

7 FURTHER RESOLVED, That nothing in this resolution condones the construction  
8 of breakwaters (in East or West portions) in the harbor; and, be it


