3 Resolution authorizing the lease of real property at 45 Leland Avenue for  
4 the Library.

5 WHEREAS, The term of the lease shall be for three years commencing  
6 upon approval of the transaction by the Board of Supervisors and Mayor and  
7 substantial completion of the tenant improvements. If funds are not appropriated  
8 in any subsequent fiscal year, City may terminate the lease upon reasonable  
9 notice to Landlord, and,  
10

11 WHEREAS, The base monthly rent shall be \$3,105 net of utilities and  
12 janitorial services for 2,300 square feet subject to annual CPI adjustments of no  
13 less than 3% with a 6% ceiling. There is an additional monthly rental cost of  
14 approximately \$598 to amortize the estimated cost of required tenant  
15 improvements not to exceed \$18,000 over the term of the lease, which includes a  
16 10% carrying cost. Should the actual cost of construction be less than \$18,000,  
17 the amortized monthly payment shall be adjusted to reflect the lesser amount,  
18 and

20 WHEREAS, City shall hold Landlord harmless from any claims or liability  
21 for any injury or damage to any person or property occurring in or about the  
22 leased premises resulting from the negligence of City, its agents or employees,

1 WHEREAS, Said lease shall be subject to certification by the Controller  
2 pursuant to Section 3.105 of the Charter, and,


4 WHEREAS, The City Attorney shall approve the form of the lease; now,  
5 therefore, be it


6 RESOLVED, That the Board of Supervisors authorizes the Director of  
7 Property to enter into the lease on file with the Clerk of the Board of Supervisors  
8 and any amendment or modifications to the lease that the Director of Property  
9 determines, in accordance with the City Attorney, are in the best interest of the  
10 City, do not increase the rent or otherwise materially increase the obligations or  
11 liabilities of the City, are necessary or advisable to effectuate the purposes of the  
12 lease or this resolution, and are in compliance with all applicable laws including  
13 City's Charter, and be it

16 the City with respect to such lease are hereby approved, confirmed and ratified.
