17 the City the opportunity to register as domestic partners with  
18 the San Francisco County Clerk and to have their partnership  
19 celebrated in an official commitment ceremony memorialized by  
20 issuance of a Domestic Partnership Ceremony Certificate; and,

21 WHEREAS, Domestic partners who do not reside or work in the  
22 City may not register with the County Clerk's Office for an  
23 official commitment ceremony memorialized by issuance of a  
24 Domestic Partnership Ceremony Certificate; and,




