Resolution authorizing the Airport Commission to accept and expend a Grant In the amount of \$99,000 from the Bay Area Air Quality Management District (Air District) for acquisition of compressed natural gas (CNG) autos and vans by Airport permittees.

WHEREAS, Pursuant to its Clean Vehicle Policy, the Airport seeks to reduce vehicle emissions in the region and on terminal roadways; and,

WHEREAS, The Air District assists public agencies in implementing emissions reduction projects, such as the addition of CNG vehicles to fleets; and,

WHEREAS, The Airport Commission in Resolution 00-0188, approved seeking, accepting, and expending Air District funds for natural gas vehicles in 2000-01; and,

WHEREAS, The Airport would administer this grant, disburse incentive funds to Airport permittees in partial payment of vehicle acquisition costs, and provide the Air District with information concerning the new vehicles; and

WHEREAS, No Airport funds would be used for this program; and

WHEREAS, This demonstration project would continue the Airport's reputation as a regional leader in promoting clean fuel use among ground transportation providers; and

WHEREAS, The Airport proposes to maximize use of available grant funds on program expenditures by not including indirect costs in the grant budget; now, therefore, be it



FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and be it


