2 RESOLUTION URGING THE CONTROLLER, MAYOR'S OFFICE OF PUBLIC FINANCE,
3 DEPARTMENT OF THE ENVIRONMENT, PUBLIC UTILITIES COMMISSION AND OTHER
4 APPLICABLE DEPARTMENTS TO ASSIST IN CRAFTING A SOLAR ENERGY BOND FOR
5 CONSIDERATION ON THE NOVEMBER 2001 BALLOT TO PROVIDE FUNDING FOR
6 SOLAR POWER TECHNOLOGY TO BE USED ON SAN FRANCISCO PUBLIC BUILDINGS
7 AND LAND.

9 WHEREAS, California's energy crisis has made it necessary to
10 rethink the way in which San Francisco gets its electricity; and,

11 WHEREAS, the single biggest contributor to global warming is
12 pollution from coal and oil fired power plants; and,

13 WHEREAS, the majority of the world's Nobel prize winning
14 scientists have signed a letter to the United Nations stating that
15 global warming is the single biggest threat to the planet; and,

16 WHEREAS, solar energy offers a clean, reliable, silent way to
17 make electricity that will help make our energy supply more secure
18 while reducing greenhouse gases; and,

19 WHEREAS, solar energy systems are remarkably durable as
20 evidenced by the fact that the first solar arrays installed forty
21 years ago are still in operation; and,

22 WHEREAS, because of our technology-based economy, San Francisco
23 is more dependent on electricity than ever before; and,

24 WHEREAS, as an earthquake-prone city, San Francisco is
25 especially vulnerable to grid failures; and,

1 WHEREAS, solar energy systems generate electricity at the source
2 where it is consumed and will provide power even when the electrical
3 grid fails; and,

4 WHEREAS, the California Energy Commission has a Renewables Buy
5 Down Program that will subsidize approximately 20% of the cost of a
6 solar electric array for Californians who choose to buy systems for
7 their homes or businesses; and,

8 WHEREAS, San Francisco should set the gold standard when it
9 comes to environmentally sound practices and energy production; now,
10 therefore, be it

11 RESOLVED, That the Board of Supervisors urges the Controller,
12 Mayor's Office of Public Finance, Department of the Environment,
13 Public Utilities Commission and other applicable departments to
14 assist in crafting a solar energy bond for consideration on the
15 November 2001 ballot to provide funding for solar power technology to
16 be used on San Francisco public buildings and land.
