3 **Resolution appointing David Parker and David Lee Crosby, terms ending December 31,**
4 **2002, and Julie Pasadas, term ending June 30, 2003, to the Delinquency Prevention**
5 **Commission; waiving residency requirement.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 does hereby appoint the hereinafter designated persons to serve as members of the
9 Delinquency Prevention Commission, pursuant to the provisions of the San Francisco
10 Administrative Code, Section 20.51, for the term specified:

11 David Parker, succeeding Cynthia Seymour, (Seat No. 2, must have interest in and be
12 knowledgeable regarding juvenile delinquency prevention), for the unexpired portion of a four-
13 year term ending December 31, 2002;

14 David Lee Crosby, succeeding Enola Maxwell, (Seat No. 3, must have interest in and
15 be knowledgeable regarding juvenile delinquency prevention), for the unexpired portion of a
16 four-year term ending December 31, 2002;

17 Julie Pasadas (residency requirement waived), succeeding Maria Rosa Navarro,
18 (Seat No. 19, must have interest in and be knowledgeable regarding juvenile delinquency
19 prevention), for the unexpired portion of a four-year term ending June 30, 2003; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 21 1. The membership of the Delinquency Prevention Commission has a goal to be
22 representative of the diversity of the City and County of San Francisco.
- 23 2. Applicant Julie Pasadas, a new appointee, who is not a resident of San Francisco,
24 is a person with experience that uniquely qualifies him/her to serve on the
25 Delinquency Prevention Commission.

The Delinquency Prevention Commission has attempted to fill the position, for which Julie Pasadas was nominated, with an individual who is a City resident and who has the specific experience, skills, and qualifications, but has been unable to do so at this time. The Rules Committee has certified that Julie Pasadas is qualified to serve on the Delinquency Prevention Commission.

4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Delinquency Prevention Commission at this time; and, be it

FURTHER RESOLVED, That the Board of Supervisors waives the residency requirement for Julie Pasadas, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.




