3 **Resolution Extending The Prescribed Time Within Which The Planning Commission**  
4 **May Render Its Decision On A Proposed Ordinance To Amend The Planning Code**

7 WHEREAS, On December 4, 2000, the Board of Supervisors initiated the process to  
8 amend the Planning Code, when the Honorable Mark Leno introduced a proposed ordinance  
9 to adopt amendments to the Planning Code relating to dwelling units, a copy of which is on file  
10 with the Clerk of the Board of Supervisors in File No. 002108; and,

11 WHEREAS, On December 9, 2000 the proposed ordinance was referred to the  
12 Planning Commission, which currently is reviewing the proposed ordinance; and,

13 WHEREAS, The Planning Department has requested additional time to review the  
14 proposed ordinance; and,

15 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by  
16 resolution, extend the prescribed time within which the Planning Commission is to render its  
17 decision on proposed amendments to the Planning Code initiated by the Board of  
18 Supervisors; and,

19 WHEREAS, The Board deems it appropriate in this instance to grant to the Planning  
20 Commission an additional 365 days to review the proposed ordinance and render its decision;  
21 now, therefore, be it

22 RESOLVED, That by this resolution, the Board hereby extends the prescribed time  
23 within which the Planning Commission may render its decision on the proposed ordinance to

1 adopt an inclusionary affordable housing program, a copy of which is on file with the Clerk of  
2 the Board of Supervisors in File No. 002108, for an additional 365 days.


