

1 [Agreement with Caltrans concerning bicycle transit improvements at Cesar Chavez]

3 **Resolution approving the Cooperative Agreement between the City and County of San**  
4 **Francisco and the State of California Department of Transportation concerning the**  
5 **construction and financing of a bicycle overcrossing and at-grade pedestrian/bicycle**  
6 **path widening on Highway 101 at Cesar Chavez Street in San Francisco and directing**  
7 **and ratifying certain actions in connection with this Resolution.**

9 WHEREAS, The City and County of San Francisco and State of California Department  
10 of Transportation ("Caltrans") desire to construct an 89.6 meter long and 3.71 meter wide  
11 bicycle overcrossing with screening and lighting and an at-grade pedestrian/bicycle path  
12 widening on Highway 101 at Cesar Chavez Street in San Francisco; and,

13 WHEREAS, San Francisco and Caltrans desire to effectuate an agreement that defines  
14 the terms and conditions under which said bicycle transit improvements are to be engineered,  
15 constructed, and maintained (the "Cooperative Agreement"); and,

16 WHEREAS, Said Agreement provides that San Francisco will engineer and construct  
17 the bicycle transit improvements and Caltrans will maintain said improvements once  
18 constructed; and,

19 WHEREAS, The construction of the bicycle overcrossing and at-grade  
20 pedestrian/bicycle path widening will improve vehicular, pedestrian, and bicycle flow in the  
21 area; and,

22 WHEREAS, San Francisco Department of Public Works has completed the design  
23 process for the bicycle transit improvements and Caltrans has approved said design; and

24 WHEREAS, The Department of Public Works and Caltrans have reviewed and  
25 approved the Cooperative Agreement; and,

1           WHEREAS, The Cooperative Agreement is on file with the Clerk of the Board of  
2 Supervisors in File No. 010532 , and is hereby incorporated by reference as though full set  
3 forth herein; and,

4           WHEREAS, The Department of Public Works in DPW Order No. 172,858, which is on  
5 file with the Clerk of the Board of Supervisors in File No. <sup>010532</sup> , has recommended that this  
6 Board approve the Cooperative Agreement; now, therefore, be it


7           RESOLVED, That the Board of Supervisors accepts and approves DPW Order  
8 No. 172,858 and the Cooperative Agreement; and, be it

9           FURTHER RESOLVED, That this Board directs the Clerk to send four (4) certified  
10 copies of this Resolution to Caltrans at an address to be provided by the Director of the  
11 Department of Public Works; and, be it

12           FURTHER RESOLVED, That this Board hereby approves, confirms, and ratifies all  
13 actions heretofore taken by the officers of the City with respect to such Cooperative  
14 Agreement and the aforementioned bicycle transit improvements, and authorizes and directs  
15 the Clerk of the Board and the Director of the Department of Public Works to take any and all  
16 actions which they or the City Attorney may deem necessary or advisable in order to  
17 effectuate the purpose and intent of this Resolution.
