WHEREAS, This endowment will be used to ensure the continued viability of extracurricular activities that contribute to a richer, more balanced student experience at Lowell High, and to improve the morale and effectiveness of athletic programs; and

WHEREAS, This endowment will additionally ensure that students have access to safe, modern equipment and facilities, and will provide after school activities for at-risk youth that are fun, encourage excellence and build character and self-esteem; now, therefore, be it




