3 **Resolution commending Oscar Olivera and La Coordinadora for their successful**  
4 **efforts to combat water privatization in Bolivia.**

6 WHEREAS, Privatization of water in the City of Cochabamba, Bolivia led to rate  
7 increases of as much as 300% by Aguas del Tunari, a Bolivian subsidiary of Bechtel  
8 Corporation, impacting some of South America's poorest people; and

9 WHEREAS, The law that privatized the water system forced families who had built  
10 wells or irrigation systems decades earlier to pay Bechtel for the right to use their water; and,

11 WHEREAS, Many of the citizens of Cochabamba suddenly found themselves unable  
12 to afford water for drinking or irrigation; and,

13 WHEREAS, Oscar Olivera, executive secretary of the Cochabamba Federation of  
14 Factory Workers helped form the Coalition in Defense of Water and Life (La Coordinadora), a  
15 new alliance of peasants, professionals, human rights, labor and community leaders who  
16 came together to demand reform of the water system; and,

17 WHEREAS, The Bolivian government refused to release the terms of the water  
18 contract, and Olivera and La Coordinadora led street protests that shut down the City for  
19 days, calling for public control of the water system; and,

20 WHEREAS, An emergency session of the Bolivian Congress in April 2000 was called  
21 to cancel the contract with Bechtel, and water was de-privatized and returned to local control;  
22 and,

23 WHEREAS, San Franciscans joined in international solidarity by sending e-mails and  
24 letters to Bechtel demanding its departure from Bolivia; and,

1           WHEREAS, Oscar Olivera continues to head La Coordinadora's work to develop a  
2 water system with local, public control; now, therefore, be it

3           RESOLVED, That the San Francisco Board of Supervisors commends Oscar Olivera  
4 and La Coordinadora for their bravery, leadership and humanitarianism.




