6 WHEREAS, There have been a number of incidents in San  
7 Francisco and the entire country that have tarnished the  
8 reputation of youth, despite the recorded decrease in juvenile  
9 crimes since 1994; and,

10 WHEREAS, Youth community involvement has been rising  
11 locally with organizations such as Coleman Advocates for Youth,  
12 the Youth Leadership Institute, and the San Francisco Youth  
13 Commission; and,

14 WHEREAS, San Francisco youth have been effective advocates  
15 for their cause, prompting measures to be passed such as the  
16 Children's Fund, which allocates \$22,000,000 to 180 youth  
17 programs around the City serving about 80,000 youth; and,

18 WHEREAS, San Francisco youth have a record of working to  
19 foster good will with their fellow citizens through local school  
20 programs and community organizations; and,

21 WHEREAS, The City and County of San Francisco should  
22 support programs that encourage young people to make  
23 contributions to society, rather than putting unnecessary  
24 emphasis on reprimanding youth for their disobedience; now,  
25 therefore be it
