9 WHEREAS, The Laurel Hill Nursery School is the city’s oldest and largest cooperative  
10 preschool and has been serving the community since 1946; and

11 WHEREAS, The Laurel Hill Nursery School offers families the joy of observing their  
12 children experience their first educational experience in a child-centered environment; and

13 WHEREAS, The Laurel Hill Nursery School offers parents the opportunity to participate  
14 in parent & consumer education and citizen-activist building; and

15 WHEREAS, The Laurel Hill Nursery School offers parents the formation of professional  
16 teaching staff and a Parent led Board of Directors who are committed to enrolling a  
17 population which reflects all of the diversity of the City, including ethnic & socio-economic  
18 groups; and

19 WHEREAS, the uniqueness of Laurel Hill is its play yard, which encompasses over  
20 9,000 square feet, and

21 WHEREAS, the play yard was last renovated over a quarter of a century ago; and

22 WHEREAS, In 1997, in order to meet current safety standards and comply with the  
23 Americans with Disabilities Act, the School conceived of its first ever capital campaign, known  
24 as the “Building the Future”; and

1           WHEREAS, The combined efforts of over 250 alumni and current family donors,  
2 foundations including the Miriam & Peter Haas Foundation, the Morris Studsaft Foundation  
3 and the David B. Gold Foundation, and the Quality Child Care Initiative, raised over \$150,000  
4 which allowed for the renovation work to begin in the summer of 2000 and is currently near  
5 completion, now, therefore, be it

6           RESOLVED, That the City and County of San Francisco Board of Supervisors does  
7 hereby commend the Laurel Hill Nursery School for the success of its first ever Capital  
8 Campaign, known as "Building the Future", which began in 1997, for renovations needed in  
9 order to meet current safety standards and to comply with the Americans with Disabilities Act.




