2 **Resolution authorizing the Department of Public Works to accept and expend a grant in**
3 **the amount of \$2,342,000 in federal Revenue-Aligned Budget Authority (RABA) funds**
4 **with required local matching funds of \$303,431 for the 3rd Street Light Rail Street**
5 **Resurfacing Project.**

7 WHEREAS, The Revenue-Aligned Budget Authority (RABA) provisions
8 of the Transportation Equity Act for the 21st Century (TEA-21) provide
9 that excess federal gas tax revenues be apportioned to states and
10 metropolitan areas for use on eligible transportation projects; and

11 WHEREAS, The San Francisco County Transportation Authority has
12 recommended programming \$2,342,000 in RABA funds for the Department
13 of Public Works' (DPW) 3rd St. Light Rail Street Resurfacing Project,
14 to be adopted by the Metropolitan Transportation Commission and
15 approved by the Federal Highway Administration (FHWA); and,

16 WHEREAS, The federal funding will cover 88.5 percent of eligible
17 costs as defined by the FHWA and administered by the California
18 Department of Transportation; and,

19 WHEREAS, Indirect costs are ineligible according to FHWA rules
20 and regulations; and,

21 WHEREAS, The non-federal share will be paid for with local half-
22 cent sales tax administered by the San Francisco County
23 Transportation Authority totaling \$303,431; and,

24 WHEREAS, The Department of Public Works understands that the
25 total amount of RABA funds for the aforementioned projects is fixed






