9 WHEREAS, The San Francisco Board of Education is committed to provide a quality
10 education to San Francisco's children; and

11 WHEREAS, The Board of Education's ability to provide this quality education has been
12 impeded by mismanagement and lack of financial controls under the administration of the
13 Superintendent Bill Rojas; and,

14 WHEREAS, Mr. Rojas was party to a land swap with the Recreation and Park
15 Department where the School District transferred a parcel to the City and County of San
16 Francisco worth more than the parcel it received; and,

17 WHEREAS, Mr. Rojas testified to the Neighborhood Services and Parks Committee
18 that this swap had no monetary component; and,

19 WHEREAS, \$800,000 sits in an account that could be used for the building of a Bessie
20 Carmichael Elementary School that was never claimed by Superintendent Rojas; and,

21 WHEREAS, This type of shoddy financial management is what is being investigated;
22 now, therefore, be it

23 **RESOLVED**, That the San Francisco Board of Supervisors urges Superintendent Bill
24 Rojas to cooperate fully with all investigations into mismanagement during his tenure, and to
25 respond truthfully to all questions asked.




