9 first year of a two year pilot project to enhance medication adherence for clients of
10 Community Mental Health Services; and,

12 WHEREAS, As a condition of receiving the grant funds, Lilly requires the City to
13 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of
14 the Board of Supervisors in File No. 010777, which is hereby declared to be a part
15 of this resolution as if set forth fully herein; and,

17 WHEREAS, SFDPH proposes to maximize the use of available grant funds on
18 program expenditures by not including indirect costs in the grant budget; now,
19 therefore, be it


20 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect
