3 **Resolution authorizing the Department of Public Health to accept and expend a grant in**
4 **the amount of ~~\$62,687~~^{\$54,705} from the State of California Department of Alcohol and Drug**
5 **Programs for substance abuse treatment services for certain non-violent drug**
6 **possession offenders as required by Proposition 36: Substance Abuse and Crime**
7 **Prevention Act of 2000.**

9 WHEREAS, The voters of the State of California passed Proposition 36: Substance
10 Abuse and Crime Prevention Act of 2000; and,

11 WHEREAS, Proposition 36 requires certain non-violent drug possession offenders to
12 receive substance abuse treatment in the community rather than be incarcerated ; and,

13 WHEREAS, Proposition 36 services are mandated to begin July 1, 2001, start-up costs
14 are allowed and are necessary for program development; and,

15 WHEREAS, The Fiscal Year 2000/2001 allocation for Proposition 36 is \$2,298,950, the
16 Department of Public Health is requesting authorization to accept and expend ~~\$62,687~~^{\$54,705} for the
17 current Fiscal Year 2000/2001 with the remaining \$2,236,263 to be appropriated by the Board
18 of Supervisors in the Fiscal Year 2001/2002 Budget; and,

19 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
20 therefore, be it

21 RESOLVED, That the Department of Public Health, Community Substance Abuse
22 Services, is hereby authorized to accept and expend the grant funds pursuant to San
23 Francisco Administrative Code section 10.170-1; and be it



FURTHER RESOLVED, That the Board of Supervisors hereby waives the inclusion of indirect costs in the grant budget; and be it


FURTHER RESOLVED, That the Controller should be urged to designate the positions funded under this grant as "G" or grant funded positions, which would terminate when the grant expires.
