3 AND EXPEND A GRANT IN THE TOTAL AMOUNT OF \$500,000 FROM THE STATE

7 WHEREAS, The Legislature and Governor of the State of California  
8 have approved a grant of \$500,000 for capital improvements to the  
9 National AIDS Memorial Grove in Golden Gate Park; and,

10 WHEREAS, The State Department of Parks and Recreation has been  
11 delegated the responsibility for the administration of this grant  
12 project, setting up necessary procedures; and,

13 WHEREAS, Said procedures established by the State Department of  
14 Parks and Recreation require the applicant to certify by resolution  
15 the approval of an application for the above project before  
16 submission of said application to the State; and,

17 WHEREAS, The applicant will enter into an agreement with the  
18 State of California for the subject project; and,


19 WHEREAS, The Department proposes to maximize use of available  
20 grant funds on program expenditures by not including indirect costs  
21 in the grant budget; now, therefore, be it

22 RESOLVED, That the City and County of San Francisco Board of


1. Approves the application, acceptance, and expenditure of \$500,000 for capital improvements to the National AIDS Memorial Grove in Golden Gate Park;
2. Certifies that the City and County of San Francisco Recreation and Park Department is in accordance with the general provisions of the agreement with the State of California;
3. Certifies that the City and County of San Francisco has sufficient funds to operate and maintain the project funded under this program;
4. Certifies that the Recreation and Park Department has reviewed and understands the General Provisions contained in the State/local agreement shown in the Procedural Guide;
5. Appoints the General Manager or Acting General Manager as agent of the Recreation and Park Department to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, payment requests and so on, which may be necessary for the completion of the aforementioned project; and
6. Waives inclusion of indirect costs in the grant budget.




