3 **Resolution approving the modification of the contract between the City and County of**
4 **San Francisco and the IHSS Consortium of San Francisco for the provision of In-Home**
5 **Supportive Services for the period from July 1, ¹⁹⁹⁹2000 to June 30, 2001, in the increased**
6 **amount of ~~\$453,750~~ ^{\$2,074,688}, for a total contract amount of \$18,207,501.**

8 WHEREAS, The City and County of San Francisco approved the contract with the
9 IHSS Consortium of San Francisco, on file with the Clerk of the Board of Supervisors in File
10 No. 98-0935, which is hereby declared to be a part of this resolution as if set forth fully herein;
11 and,

12 WHEREAS, In October 1999, in anticipation of passage of a minimum compensation
13 ordinance, the Board of Supervisors approved an increase in provider wages for employees of
14 the IHSS Consortium in the amount of \$1,620,938, in the DHS 1999-2000 budget; and
15 because of a procedural misunderstanding DHS did not obtain separate and additional Board
16 approval for the actual contract modification; and

17 WHEREAS, The City and County of San Francisco Board of Supervisors passed the
18 Minimum Compensation Ordinance; and,

19 WHEREAS, The Department of Human Services has allocated additional funds in their
20 budget to increase the average wage of the IHSS contract workers to \$9.70 per hour; and

21 WHEREAS, The City and County of San Francisco Board of Supervisors approved the
22 Department of Human Services budget which includes the additional funds; and

23 WHEREAS, The Human Services Commission has recommended approval of this
24 contract modification with the IHSS Consortium of San Francisco at its meeting of July 27,
25 2000; now, therefore, be it

1 RESOLVED, That the Board of Supervisors hereby approves the modification of this
2 contract with the IHSS Consortium of San Francisco for the period of July 1, 1999 to June 30,
3 2001, in the increased amount of \$1,620,938, for a total contract amount of \$17,753,751;and
4 be it further

5 RESOLVED, That the Board of Supervisors hereby approves the modification of this
6 contract with the IHSS Consortium of San Francisco for the period of July 1, 2000 to June 30,
7 2001, in the increased amount of \$453,750, for a total contract amount of \$18,207,501.




