AUTHORIZING THE ARTS COMMISSION AND THE RECREATION AND PARK
DEPARTMENT JOINTLY TO APPLY, ACCEPT AND EXPEND A GRANT IN THE TOTAL
AMOUNT OF \$189,000 FROM THE STATE 2000 BOND ACT FOR THE RECREATION
AND PARK DEPARTMENT'S YOUTH STEWARDSHIP PROGRAM (\$94,500) AND THE
BAYVIEW OPERA HOUSE (\$94,500).

WHEREAS, The Legislature and Governor of the State of California
have approved a grant of \$189,000 to support the Recreation and Park
Department's Youth Stewardship Program with \$94,500, and for a youth
mural project at the Bayview Opera House with \$94,500; and,

WHEREAS, The State Department of Parks and Recreation has been
delegated the responsibility for the administration of this grant
project, setting up necessary procedures; and,

WHEREAS, Said procedures established by the State Department of
Parks and Recreation require the applicants to certify by resolution
the approval of applications for the above projects before submission
of said applications to the State; and,

WHEREAS, The applicants will enter into separate agreements with
the State of California for the subject projects; and,

WHEREAS, The grant terms prohibit including indirect costs in
the grant budget; now, therefore, be it

Supervisors hereby:



- 1 1. Approves the application, acceptance, and expenditure of

- 5 2. Certifies that the City and County of San Francisco Recreation
6 and Park Department and the Arts Commission are in accordance
7 with the general provisions of the agreements with the State of
8 California;
- 9 3. Certifies that the City and County of San Francisco has
10 sufficient funds to operate and maintain the projects funded
11 under this program;
- 12 4. Certifies that the Arts Commission and the Recreation and Park
13 Department have reviewed and understands the general provisions
14 contained in the State/local agreement shown in the Procedural
15 Guide;
- 16 5. Appoints the Director as agent of the Arts Commission, or the
17 General Manager or Acting General Manager as agent of the
18 Recreation and Park Department, to conduct all negotiations,
19 execute and submit all documents, including but not limited to
20 applications, agreements, payment requests and so on, which may
21 be necessary for the completion of the respective,
22 aforementioned projects; and
- 23 6. Waives inclusion of indirect costs in the grant budget.
