2 **Resolution determining that the transfer of a Type 21 off-sale general alcoholic**
3 **beverage control license from 1172 Geneva Avenue to 757 Beach Street to Anuar**
4 **Abu-Arafeh for Alcatraz Market will serve the public convenience and necessity of**
5 **the people of the City and County of San Francisco, in accordance with section**
6 **23958.4 of the California Business and Professions Code; with conditions.**

8 WHEREAS, Anuar Abu-Arafeh is seeking transfer of a Type 21 off-sale general
9 alcoholic beverage control license for Alcatraz Market located at 757 Beach Street; and,

10 WHEREAS, The City Planning Department has verified that the area is properly
11 zoned; and,

12 WHEREAS, The Police Department recommends that the liquor license
13 application be approved with conditions; now, therefore, be it

14 RESOLVED, That in accordance with Section 23958.4 of the California Business
15 and Professions Code, the Board of Supervisors of the City and County of San
16 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21
17 off-sale general alcoholic beverage control license from 1172 Geneva Avenue to 757
18 Beach Street for Anuar Abu-Arafeh for Alcatraz Market, will serve the public
19 convenience and necessity of the people of the City and County of San Francisco.

20 Conditions: 1) The hours of operation shall not exceed 8:00 a.m. to 11:00 p.m.
21 each day of the week. 2) The petitioner shall be responsible for maintaining free of litter
22 the area in front of and adjacent to the premises over which they have control. 3) The
23 sales of beer or malt beverages in quantities of quarts, 22 oz., 32 oz., 40 oz., or similar
24 size containers is prohibited. No beer or malt beverages shall be sold in quantities of
25 less than six per sale. 4) Beer, malt beverages, and wine coolers in containers of 16 oz.

1 or less cannot be sold by single containers, but must be sold in manufacturer pre-
2 packaged multi-unit quantities.




