

1 [Resolution allowing the Director of Public Works to accept and expend a \$1,000,000 state
2 grant for beach nourishment and long-term planning activities at Ocean Beach]

4 **Resolution authorizing the Director of Public Works to accept and expend a grant in the**
5 **amount of \$1,000,000 from the California Public Beach Restoration Program with**
6 **required local matching funds of \$150,000 for the Ocean Beach Erosion Control**
7 **Project.**

9 WHEREAS, The California Public Beach Restoration Act (the Act) was passed by the
10 Legislature and signed by the Governor in October 1999 for specified public beach
11 enhancement purposes; and,

12 WHEREAS, The Act called for the creation of the Public Beach Restoration Fund in the
13 State Treasury to be administered by the state Department of Boating and Waterways; and,

14 WHEREAS, Ocean Beach, the largest stretch of public sandy beach in San Francisco,
15 suffered severe erosion in vast sections due to harsh winter storms in recent years; and,

16 WHEREAS, Erosion also threatens the Great Highway with its sewage facility located
17 beneath the roadway that carries sewage from San Francisco's northwest quadrant to the
18 Oceanside Treatment Plant at the southern of Ocean Beach; and,

19 WHEREAS, Protection of life safety and property is most severely compromised just
20 south of Sloat Boulevard where the ocean comes within twenty-five feet of the Highway; and,

21 WHEREAS, The Department of Boating and Waterways programmed \$1,000,000 for
22 San Francisco's Ocean Beach Erosion Control Project in March 2001; and

23 WHEREAS, The state funding will cover 85 percent of eligible costs as defined and
24 administered by the Department of Boating and Waterways; and,

1 WHEREAS, Indirect costs are ineligible according to the Department of Boating and
2 Waterway's rules and regulations; and,

3 WHEREAS, The local share will be paid for with Departmental funds totaling \$150,000;
4 now, therefore, be it

5 RESOLVED, That this Board of Supervisors does hereby authorize the Director of
6 Public works to accept and expend up to \$1,000,000 from the California Public Beach
7 Restoration Program with required matching funds of \$150,000 and to execute all documents
8 required therefore.
