3 Resolution declaring June 27, 2001 "HIV Testing Day" in the City and
4 County of San Francisco and call upon all persons at risk of HIV
5 infection to take the test in the City and County of San Francisco.

7 WHEREAS, The National HIV Testing Day campaign promotes
8 prevention, education and voluntary HIV counseling, testing and
9 referral to encourage persons at risk for HIV infection to "Take the
10 Test," know their HIV status and reduce their risks for HIV
11 transmission; and

12 WHEREAS, The Centers for Disease Control and Prevention estimate
13 that between 650,000 and 900,000 Americans are infected with HIV; and

14 WHEREAS, Over 200,000 Americans do not know they are infected,
15 and may continue to engage in behavior that could jeopardize their
16 health, and the health of others; and

17 WHEREAS, The San Francisco Department of Public Health estimates
18 that 17,838 persons in San Francisco are living with HIV, and as many
19 as 3500 persons do not know that they are infected; and

20 WHEREAS, New treatments are helping those living with HIV to
21 enjoy longer lives and to receive those treatments, individuals must
22 first know whether they are infected with HIV; and

23 WHEREAS, Free, anonymous and confidential HIV testing is
24 available at locations throughout San Francisco by calling 502-TEST
25 or from the AIDShotline.org; now therefore, be it

1 RESOLVED, The Board of Supervisors of the City and County of
2 San Francisco do Hereby Declare Wednesday, June 27th, 2001, "HIV
3 Testing Day" in the City and County of San Francisco and call upon all
4 persons at risk of HIV infection to Take the Test.
