3 **Resolution authorizing the San Francisco Department of Public Health,**  
4 **retroactively**  
5 **Population Health and Prevention, to accept and expend a grant in the amount of**  
6 **\$221, 532 from the California Health and Human Services Agency, Department of**  
7 **Drug and Alcohol Programs, for the period of December 29, 2000 to December 28,**  
8 **2001, and to enter into an agreement for the use of these funds.**

9 WHEREAS, The San Francisco Department of Public Health has applied for and  
10 been awarded a grant from the California Health and Human Services Agency,  
11 Department of Drug and Alcohol Programs in the amount of \$221,532 for a project to  
12 assist the San Francisco County Juvenile Drug Court Program to enhance existing  
13 services and expand capacity in San Francisco; and,

14 WHEREAS, As a condition of receiving the grant funds, The Department of Drug  
15 and Alcohol Programs requires the City to enter into an agreement (the "Agreement"), a  
16 copy of which is on file with the Clerk of the Board of Supervisors in File  
17 No. 011095, which is hereby declared to be a part of this resolution as if set forth  
18 fully herein; and,

19 WHEREAS, The Department proposes to maximize use of available grant funds  
20 on program expenditures by not including indirect costs in the grant budget; now,


RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and, be it




FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City.


