3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code and the
6 San Francisco Traffic Code, the following regulations governing the parking of vehicles are
7 hereby enacted or rescinded as designated below:

8 **NO PARKING ANYTIME - ESTABLISH**

10 Charter Oak Avenue, east side, from Helena Street up to and including the south
terminus (including frontage along I-280 freeway)

11 Helena Street, north side, between the north property line of #100 Charter Oak Avenue
12 and the west property line of #152 Helena Street

13 Helena Street, north side, from Elmira Street to 87 feet westerly (87-foot zone, up to
14 the east property line of #148 Helena Street)

15 **NO PARKING ANYTIME - RESCIND**

16 Montgomery Street, along both sides of raised median island, between Union and
17 Greenwich Streets

18 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

19 Newcomb Avenue, north side, between Rankin and Quint Streets

20 **RESIDENTIAL PERMIT PARKING AREA "B" (2-HOUR TIME LIMIT, 9 AM - 5 PM, MONDAY
THROUGH FRIDAY) - ESTABLISH**




