3 **Resolution urging the Board of Supervisors to authorize continuing the service level**
4 **and enrollment for CalWORKS child care by renewal of the existing contract with the**
5 **Children’s Council of San Francisco, a California corporation, to continue with said**
6 **contract in enrollment, program costs and number of capacity building initiatives.**

8 WHEREAS, The California Department of Social Services (CDSS) has continued
9 service level as part of its general welfare reform legislation (“CalWORKS”) for CalWORKS
10 Stages I and II; and,

11 WHEREAS, CDSS and state CalWORKS are funding numerous capacity building
12 initiatives and,

13 WHEREAS, The Board of Supervisors of the City and County of San Francisco has
14 approved appropriation for city subsidies; and,

15 WHEREAS, The Children’s Council of San Francisco is under contract to the City and
16 County of San Francisco has provided this type of service successfully for several years, and
17 is the largest single provider of these services in the City and County of San Francisco; and,

18 WHEREAS, Under its existing contract, effective July 1, 2000, and continuing until
19 June 30, 2001, for the total amount of \$32,817,700, Children’s Council of San Francisco is the
20 largest single provider of the services covered by this legislation, namely the provision of Child
21 Care support to families who are moving from welfare to work; and,

22 WHEREAS, For purposes of efficiency and to maximize the amount of child care that
23 can be provided to eligible participants in funded programs, funds should be consolidated and
24 administered by Children’s Council of San Francisco; and,

1 WHEREAS, On June 21, 2001, the Human Services Commission approved the
2 agreement with Children's Council of San Francisco, as proposed herein; therefore be it

3 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
4 authorizes the execution of a renewal of this agreement with the Children's Council of San
5 Francisco, effective August 1, 2001 through June 30, 2003, in the amount of \$72,922,718;
6 and, be it

7 FURTHER RESOLVED, That the Executive Director of the Department of Human
8 Services is authorized to sign the contract for the City and County of San Francisco.




