3 **Resolution establishing a Presidio Neighborhood Representative Work Group to be**
4 **comprised of representatives from affected neighborhoods and City Departments.**

6 WHEREAS, On July 25, 2001, the Presidio Trust released the Presidio Trust
7 Implementation Plan (PTIP); and

8 WHEREAS, On July 25, 2001, the Presidio Trust released the Environmental Impact
9 Statement containing an analysis of the environmental impacts of developments proposed at
10 the Presidio; and,

11 WHEREAS, The City and members of the public have been given 60 days to comment
12 upon the Presidio Trust Implementation Plan and Environmental Impact Statement; and,

13 WHEREAS, The development in the Presidio will have a tremendous impact upon the
14 City's infrastructure and the demand for City services; and

15 WHEREAS, The development in the Presidio will have a tremendous impact upon the
16 neighborhoods surrounding the Presidio; now, therefore, be it

17 RESOLVED, That the Board of Supervisors does hereby establish the Presidio
18 Neighborhood Representative Work Group, which shall be subject to the mandates of the
19 Sunshine Ordinance ; and, be it

20 FURTHER RESOLVED, The Planning Department shall compile the Environmental
21 Impact Statement and Presidio Trust Implementation Plan commentary of The Presidio
22 Neighborhood Representative Work Group in a report which shall be presented to the Board
23 of Supervisors Neighborhood Services and Parks Committee; and, be it

1 FURTHER RESOLVED, The City Attorney shall assist the Planning Department in
2 compiling Work Group commentary on the Environmental Impact Statement and Presidio
3 Trust Implementation Plan and in formulating the commentary for the report; and, be it

4 FURTHER RESOLVED, That the Presidio Neighborhood Representative Work Group
5 shall include the following representatives and alternate representatives designated by the
6 following groups

7 -two representatives of the Coalition for San Francisco Neighborhoods selected by the
8 Coalition for San Francisco Neighborhoods Presidio Committee

9 -one representative of the Cow Hollow Association selected by Cow Hollow
10 Association,

11 -one representative of Cow Hollow Neighbors in Action selected by Cow Hollow
12 Neighbors in Action,

13 -one representative of the Marina Civic Improvement and Property Owners Association
14 selected by the Marina Civic Improvement and Property Owners Association,

15 -one representative of the Pacific Heights Residents Association selected by the Pacific
16 Heights Residents Association,

17 -one representative of the Planning Association for the Richmond selected by the
18 Planning Association for the Richmond,

19 -one representative of the West Presidio Neighborhood Association selected by the
20 West Presidio Neighborhood Association,

21 -one representative of the National Parks Conservation Association selected by the
22 National Parks Conservation Association,

23 -one representative of the Sierra Club selected by the Sierra Club,

24 -one representative of the Golden Gate Valley Neighborhood Association selected by
25 the Golden Gate Valley Neighborhood Association,

1 -one representative of the Marina Merchants Association selected by the Marina
2 Merchants Association,
3 -three appointees from the President of the Board of Supervisors
4 -the department heads or their designees from the Public Utilities Commission,
5 Department of Parking and Traffic, Department of Public Works, Transportation Authority,
6 MUNI, Planning Department, Controller, City Attorney, Mayor's Office of Neighborhood
7 Services, and Mayor's Office of Economic Development; and, be it

8 FURTHER RESOLVED, The Office of the Clerk of the Board shall implement any
9 legally required public notice; and, be it

10 FURTHER RESOLVED, That the Presidio Neighborhood Representative Work Group
11 shall begin meeting immediately in order to develop the City's commentary on the Presidio
12 Trust Implementation Plan and Environmental Impact Statement; and, be it

13 FURTHER RESOLVED, That this Work Group shall develop a report on the costs
14 associated and the impacts of future planning actions by the Presidio Trust; and, be it

15 FURTHER RESOLVED, That this Work Group shall report any of its finding, concerns
16 or recommendations to the Board of Supervisors during and beyond the 60 day PTIP
17 recommendation comment period regarding the Presidio.




