

1 [Urging passage of AB540]

2 Resolution urging the California State Assembly to pass AB540,
3 the Out-of-state Tuition Exemption for Immigrant Students bill.
4

5 WHEREAS, The United States Supreme Court decided in Plyler
6 v. Doe (1982) that individuals who hold "green cards" and reside
7 in the United States are entitled to an education in the K-12
8 system because their parents work and pay taxes regardless of
9 their national status; and,

10 WHEREAS, Education is not only a basic right for all
11 people, but it supports long term benefits that are in our
12 national interest to provide a better workforce that is capable
13 of meeting national production needs; and,

14 WHEREAS, San Francisco, with its long history of
15 immigration and diverse communities, has a special interest in
16 supporting education for all, regardless of immigration status;
17 and,

18 WHEREAS, Green card holders who work successfully through
19 the K-12 system and enter California colleges or universities
20 are required to pay out-of-state tuition, effectively forcing
21 them to end their education after high school; and,

22 WHEREAS, The State of Texas has already set a precedent for
23 long-time immigrants to pay in-state tuition rates for college
24 if the students had been enrolled in high school for at least
25 three years; and,

1 WHEREAS, AB540, sponsored by Assembly Member Marco Antonio
2 Firebaugh, would exempt undocumented immigrants from paying out-
3 of-state tuition, allowing them to go to college at lower in-
4 state rates if the students have attended high school for at
5 least three years and graduated; and,

6 WHEREAS, Governor Davis vetoed a similar bill last year
7 claiming that it violated federal law, and the section that
8 Davis cited has been amended to address his concerns; now,
9 therefore, be it

10 RESOLVED, That the Board of Supervisors of the City and
11 County of San Francisco urges the California State Assembly to
12 pass AB540, the Out-of-state Tuition Exemption for Immigrant
13 Students bill.




