

1 [Day of Tolerance and Respect for Human Rights]  
2 Resolution Declaring that annually September 11<sup>th</sup> shall be in San  
3 Francisco a "Day of Tolerance and Respect for Human Rights."  
4

5 WHEREAS, The City of San Francisco joins with the nation in  
6 condemning the terrorist acts of Tuesday September 11<sup>th</sup> against  
7 innocent civilians in New York City, Washington DC, and  
8 Pennsylvania; and

9 WHEREAS, It is especially critical at this time for all  
10 Americans to come together to stand up against terrorism and the  
11 intolerance of another's ethnicity, lifestyle, race, culture,  
12 nationality, or religious beliefs; and

13 WHEREAS, The Board of Supervisors of the City and County of  
14 San Francisco with the State and local PTA and other child  
15 welfare advocacy groups recognizes the critical importance of  
16 developing safer school communities, educational tolerance  
17 outreach programs, and implementing cultural sensitivity  
18 training and policy for local schools; and

19 WHEREAS, It is important to respond to terrorism by giving  
20 support to families, teachers and caregivers who struggle to  
21 create a safe environment during times of great national  
22 tragedy; and,

23 WHEREAS, It is also important to support school outreach  
24 programs that educate students about the many diverse groups  
25 that share our global community; now therefore be it

1           RESOLVED, That the San Francisco Board of Supervisors  
2 hereby proclaims September 11<sup>th</sup> of each year henceforth as San  
3 Francisco's Day of Tolerance and Respect for Human Rights, with  
4 the intention of promoting awareness of the world's diverse  
5 communities; and be it

6           FURTHER RESOLVED, That the San Francisco Board of  
7 Supervisors urges the Department of Health, Mayor's Office of  
8 Children Programs, School Boards and Administrators to work with  
9 parents, students, teachers, local law enforcement, other  
10 appropriate agencies and their school communities to promote  
11 cultural understanding among diverse communities; and be it

12           FURTHER RESOLVED, That the San Francisco Board of  
13 Supervisors urges school policymakers to support local and state  
14 efforts to, (1) reduce intolerance and hate crimes toward others  
15 of different backgrounds or beliefs, (2) increase positive  
16 community and bridge building between peoples, cultures, and the  
17 international community, and (3) implement policies for all of  
18 San Francisco's schools to address these issues especially  
19 during times of national tragedy; and be it

20           FURTHER RESOLVED, That the Department of Health redirect  
21 appropriate educational and out patient resources for the month  
22 of September to create a safer and more tolerant environment for  
23 all of San Francisco's school children while working in  
24 partnership with schools, community organizations, city, state,  
25 and appropriate federal agencies, and be it




