1 [Accept-Expend Federal Grant]

3 **Resolution authorizing the Department of Children, Youth and Their Families to**
4 **retroactively accept and expend a grant in the amount of \$24,293 from the office of**
5 **Juvenile Justice and Delinquency Prevention (OJJDP) for the Gang Free Communities**
6 **Program that is currently authorized by OJJDP, and up to \$150,000 upon receipt of the**
7 **final award letter from OJJDP.**

9 WHEREAS, the Department of Children, Youth and Their Families (DCYF) and the
10 Juvenile Probation Department (JPD) jointly responded to a competitive request for proposal
11 issued by the office of Juvenile Justice and Delinquency Prevention (OJJDP) around their
12 Gang Free Communities Program; and,

13 WHEREAS, DCYF and JPD' s proposal was successful, and OJJDP awarded the City
14 and County of San Francisco a grant in the amount of \$150,000 to collect data and develop a
15 citywide strategic plan around reducing gang violence (Strategic Plan); and,

16 WHEREAS, a requirement of OJJDP' s grant was the up front selection of a research
17 partner that met with OJJDP' s prior approval, and Resource Development Associates was so
18 named because of their expertise and experience in the field of crime data collection design
19 and assessment; and,

20 WHEREAS, substantial work that required certain expenditures needed to be done
21 prior to OJJDP' s issuance of a final award letter, and in recognition of this, OJJDP issuance
22 of a final award letter authorizing such pre-approval of expenditures up to \$24,293; and,

23 WHEREAS, a final award letter for the full amount of \$150,000 is expected within 45
24 days from the date hereof; and,

1 WHEREAS, OJJDP may award up to \$150,000 additional each year thereafter for up
2 to three years should the Strategic Plan be approved and accepted by OJJDP; now,
3 therefore, be it

4 RESOLVED, That DCYF is authorized to retroactively expend up to \$24,293 under the
5 grant; and be it

6 FURTHER RESOLVED, That upon receipt of the final grant award letter, that DCYF is
7 authorized to retroactively expend up to the full grant amount of \$150,000 and be it

8 ~~FURTHER RESOLVED, That should OJJDP accept and approve the Strategic Plan,~~
9 ~~that DCYF be authorized to expend up to \$150,000 for up to three successive years to~~
10 ~~implement the Strategic Plan; and be it~~

11 FURTHER RESOLVED, That Resource Development Associates be approved as a
12 sole source provider as the research partner per OJJDP' s grant requirement.; and be it

13 FURTHER RESOLVED, That this Project Director position at DCYF that is funded by
14 the subject grant shall be designated as a grant "G" funded position and the authorization for
15 this position shall terminate when the grant terminates.




