

1 [Urging enactment of SB71]
2 Resolution urging California Governor Gray Davis to sign SB71,
3 Senator John Burton's Worker's Compensation bill.
4

5 WHEREAS, Existing California State law provides for the
6 assessment of civil penalties for acts constituting workers'
7 compensation fraud; and,

8 WHEREAS, SB71, sponsored by Senator John Burton and passed
9 by the California State legislature would authorize use of these
10 penalty funds for investigation and prosecution of an employer's
11 willful failure to secure payment of workers' compensation; and,

12 WHEREAS, SB71 would also require the Bureau of State Audits
13 to evaluate the effectiveness of the efforts of the Fraud
14 Assessment Commission, the Bureau of Fraudulent Claims, the
15 Department of Industrial Relations, and local law enforcement
16 agencies in identifying, investigating, and prosecuting workers'
17 compensation fraud and the willful failure to secure payment of
18 workers' compensation; and,

19 WHEREAS, SB71 would also increase the civil penalty amounts
20 that could be imposed for workers' compensation fraud; and,

21 WHEREAS, Workers who are injured on the job deserve full
22 compensation and employers who willfully fail to secure payment
23 of workers compensation should be penalized appropriately; and,

24 WHEREAS, The State of California cannot expect to identify
25 employers who skirt workers compensation law unless sufficient

1 efforts are made to investigate failure to pay workers who have
2 a right to compensation under the law; and,

3 WHEREAS, SB71 includes additional penalties for workers
4 compensation fraud, making it fair-minded legislation that
5 addresses worker and employer abuse of workers compensation
6 laws; now, therefore, be it

7 RESOLVED, That the Board of Supervisors of the City and
8 County of San Francisco urges Governor Davis to sign SB71,
9 Senator John Burton's workers compensation bill.
