3 Resolution authorizing the Chief of Police for the City and County of San Francisco to
4 accept and expend grant funds made available through the Governor’s Office of
5 Criminal Justice Planning for a project entitled “James Denman Middle School Safety
6 Program” and waiving indirect costs due to funding constraint; rescinding Resolution
7 Number 674-00.

8 WHEREAS, The Chief of Police of the City and County of San Francisco has
9 undertaken a certain project designated “James Denman Middle School Safety Program”
10 pursuant to Resolution Number 674-00, to be funded from funds made available through the
11 Office of Criminal Justice Planning (herein referred to as OCJP); and,

12 WHEREAS, The San Francisco Police Department’s School Resource Officer program
13 will implement a safety program at the James Denman Middle School to improve school
14 safety, engage chronic truants in special programs and services to stay in school; and,

15 WHEREAS, The Department unknowingly omitted the need to backfill the position
16 vacated through this program, and

17 WHEREAS, The Department proposes to maximize use of available grant funds on
18 program expenditures by not including indirect costs in the grant budget due to funding
19 constraints; now, therefore, be it

20 RESOLVED, That the Chief of Police of the City and County of San Francisco is
21 authorized on behalf of the City and County of San Francisco to accept and expend continued
22 funding for this project from OCJP, and waiving indirect costs due to funding constraints; and
23 be it

24 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
25 indirect costs in the grant budget; and be it


1 FURTHER RESOLVED, That the Chief of Police is authorized to execute on behalf of
2 the City and County of San Francisco the necessary Grant Award Agreement for this project
3 including any extensions, funding augmentations from OCJP, or amendments thereof; and be
4 it

5 FURTHER RESOLVED, That it is agreed that any liability arising out of the
6 performance of this Grant Agreement, including civil court actions for damages, shall be the
7 responsibility of the grantee and the authorizing agency. The State of California and OCJP
8 disclaim responsibility for and such liability; and be it


9 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
10 supplant expenditures controlled by this body, thus, the position vacated through this program
11 will be backfilled contemporaneously with the same level of local funding by transferring
12 equivalent funds from the Police Department's uniform salary account to its overtime account
13 for each fiscal year for the duration of this grant, and be it

14 FURTHER RESOLVED, That the department is requesting that resolution 674-00 be
15 rescinded and replaced herein.
