WHEREAS, The State of California Environmental Protection Agency has approved and awarded a grant of \$50,000 for capital improvements to South Sunset Playground; and

WHEREAS, The California Integrated Waste Management Board has been delegated the responsibility for the administration of this grant project, setting up necessary procedures; and,

WHEREAS, The Recreation and Park Commission approved the South Sunset Playground improvement project on February 15, 2001 under Resolution #0102-018; and,

WHEREAS, The Recreation and Park Department will enter into an agreement with the State of California for the subject project; now, therefore, be it


RESOLVED, That the City and County of San Francisco Board of Supervisors hereby:

3. Certifies that the Recreation and Park Department has reviewed and understands the terms and conditions contained in the grant agreement; and




