15 **RESOLVED**, That the Board of Supervisors hereby authorizes the Director of  
16 Public Health and the Purchaser, on behalf of the City and County of San  
17 Francisco, to execute a contract with Health Advocates, LLP for the period  
18 beginning with the date of contract certification through December 31, 2005 to  
19 provide uncompensated care reimbursement recovery services; and, be it






