3 **Resolution designating certain intersections as "STOP" intersections.**

5 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the
6 following intersections are hereby designated as "STOP" intersections, and the Department of
7 Parking and Traffic is hereby authorized and directed to cause "STOP" signs to be installed
8 thereat as designated below:

9 STOP SIGNS - ESTABLISH

10 25th and Church Streets, northeast and southwest corners, stopping Church Street
11 (makes this an all-way STOP)

12 41st Avenue and Judah Street, northeast and southwest corners, stopping Judah
13 Street (makes this an all-way STOP)

14 Fairmount and Whitney Streets, northwest and southeast corners, stopping Whitney
15 Street (making this intersection an all-way STOP)

16 Revere Avenue and Bay View Street, northwest corner, stopping southbound Revere
17 Avenue (stops the stem of this T-intersection)

18 San Carlos and Sycamore Streets, southwest corner, stopping San Carlos Street
(stops the stem of this T-intersection)

19 STOP SIGNS - RESCIND

20 Lincoln Way and 3rd Avenue, southeast corner, stopping northbound 3rd Avenue




