3 **Resolution Approving the Airport Public Facilities Operating Agreement between**  
4 **Ampco System Parking and the City and County of San Francisco, Acting by and**  
5 **through its Airport Commission.**

7 WHEREAS, The Airport Commission authorized the issuance of the Request for  
8 Qualification/Proposal for the Airport Public Parking Facilities Operating Agreement; and

9 WHEREAS, A five member panel reviewed and rated the qualifying proposal and oral  
10 presentations in accordance with the Commission-approved selection criteria and,

11 WHEREAS, The five member panel determined that Ampco System Parking was the  
12 best responsive and responsible proposer; and

13 WHEREAS, The Human Rights Commission (HRC) has determined that Ampco  
14 System Parking has, directly or through good faith efforts, achieved the Minority-Owned  
15 Business Enterprise (MBE/WBE) sub-consulting goals for this agreement; and

16 WHEREAS, the total annual cost proposal for this Agreement is \$19,338,354.00, which  
17 includes \$1,489,079.00 in Management Fees; now, therefore, be it

18 RESOLVED, That the Board of Supervisors hereby approves the Airport Public Parking  
19 Facilities Operating Agreement by and between Ampco System Parking, and the City and  
20 County of San Francisco, acting by and through its Airport Commission, for a one-year term at  
21 an annual cost not to exceed \$19,338,354.00, which includes \$1,489,079.00 in Management  
22 fees, for the first year of the agreement, and up to four one-year options exercisable at the  
23 sole discretion of the Airport, copies of which are contained in Board of Supervisors' File  
24 Number 011884.




