13 zoned; and recommends approval; and

14 WHEREAS, The Police Department recommends that the liquor license
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business
17 and Professions Code, the Board of Supervisors of the City and County of San
18 Francisco hereby determines for the foregoing reasons that the issuance of a Type 48
19 on-sale general public premises liquor license in exchange for a Type 47 on-sale
20 general eating place liquor license, to Peter Garcia for Zodiac Club LLC, located at 718
21 14th Street (District 8) will serve the public convenience and necessity of the people of
22 the City and County of San Francisco.

23 Conditions: (1) Sales and service of alcoholic beverages shall be permitted only
24 between the hours of 5:00 p.m. and 2:00 a.m. each day of the week. (2) The petitioner

1 shall be responsible for maintaining free of litter the area adjacent to the premises over
2 which they have control.




