10 Family Violence and Services Program; and,

11 WHEREAS, Due to the need for increased awareness of the issue of family violence
12 and the need for prevention efforts, the Sheriff's Department will provide a public information
13 community awareness campaign for the prevention of family violence; and,

14 WHEREAS, The grant identifies non-federal funds of \$27,100; and,

15 WHEREAS, the Sheriff's Department proposes to maximize use of available grant
16 funds on program expenditures by not including indirect costs in the grant budget; now,
17 therefore, be it

18 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
19 the grant budget; and be it


20 FURTHER RESOLVED, That a grant award notification has been received from the U.
