2 Resolution increasing civil filing and appearance fees provided
3 in Business and Professions Code Sections 6321, 6322 and 6322.1
4 for operation of the Law Library

6 WHEREAS, The Law Library's filing fee income is inadequate
7 to meet present and anticipated future operating costs of the
8 Law Library: legal publication costs, salaries and general
9 operating expenses have increased and are expected to increase
10 yearly, so that an increase in the filing and appearance fees
11 pursuant to Section 6322.1 of the Business and Professions Code
12 of the State of California fund Law Library operations is
13 required; and,

14 WHEREAS, California Business and Professions Code section
15 6322.1 empowers this Board of Supervisors to increase Law
16 Library civil filing fees from \$27.00 to \$30.00 by excluding the
17 increase from the definition of "total fee" provided in sections
18 26820.6 and 72055 of the Government Code; and

19 WHEREAS, The increased fee does not affect the City and
20 County General Fund or the Trial Court Trust Fund established by
21 Government Code section 68085; now, therefore, be it

22 RESOLVED, That the Board of Supervisors of the City and
23 County of San Francisco hereby orders that the fees for use of
24 the Law Library, provided in sections 6321 and 6322 of the
25 California Business and Professions Code be increased from

4 FURTHER RESOLVED, That pursuant to Government Code section
5 6322.1, the three dollar (\$3.00) increase in Law Library filing
6 fees is specifically excluded from the definition of "total
7 filing fee" in the above-referenced provisions of the Government
8 Code, and therefore, that three dollars (\$3.00) of the fee be
9 added to the total filing fees in Superior Court, unlimited
10 jurisdiction and limited jurisdiction civil division; and be it

11 FURTHER RESOLVED, that the Superior Court, unlimited
12 jurisdiction and limited jurisdiction civil division, of the
13 City and County of San Francisco is hereby authorized and
14 directed to collect the sum of \$30.00 in the Superior Court,
15 unlimited jurisdiction and limited jurisdiction civil division,
16 for the use of the Law Library, for each filing and appearance
17 described in Sections 6321 and 6322 of said code, from January
18 1, 2002, and to pay the same over to the Treasurer of the San
19 Francisco Law Library in the manner provided by law; and be it

20 FURTHER RESOLVED, that the Clerk of the Board of
21 Supervisors be and is hereby directed to deliver copies of this
22 resolution, duly certified, to the Superior Court, unlimited
23 jurisdiction and limited jurisdiction civil division, of the
24 City and County of San Francisco.




