[Definition of Homelessness]

Resolution establishing an official citywide definition of homelessness for San Francisco to enable all City Departments and community based organizations to communicate and share information on the homeless population using the same terms and parameters.

WHEREAS, The City and County of San Francisco provides shelter, support and health and human services to the City's homeless population; and

WHEREAS, The City and County of San Francisco does not have an official definition of homelessness and many different definitions of homelessness exist in the system including a Federal definition, departmental definitions, and grant driven definitions; and

WHEREAS, The policy making bodies of the City and County of San Francisco, the Board of Supervisors, the Local Homeless Coordinating Board and the Mayor are grappling with the costs of homelessness to the City; and

WHEREAS, The Board of Supervisors has asked the Budget Analyst to update the homeless costs based on the formula used in 1995; and

WHEREAS, A number of City Departments have attempted to define the services provided to the homeless through qualitative and quantitative analysis; and

WHEREAS, The Department of Public Health established a working definition of homelessness in the Fall of 2000 to assist in the goal of improving homeless services and in an attempt to inventory homeless programs within the Department; and

WHEREAS, The DPH definition of "HOMELESS" includes individuals or families who lack a fixed, regular, and adequate nighttime residence and who have a primary nighttime

1 residence in one or more of the following categories: Shelter, Street, Vehicle, Make-Shift,
2 Doubled-Up, and Transitional; and

3 WHEREAS, The Department of Human Services, the Local Homeless Coordinating
4 Board and the Single Room Occupancy Task Force have all adopted this same working
5 definition; and

6 WHEREAS, The Local Board is a key voice in the development of homeless policy
7 made by the City and County of San Francisco; Now Therefore, Be It

8 RESOLVED, That the San Francisco Board of Supervisors formally adopt this definition
9 of homelessness as the City and County's official definition; And, Be It

10 FURTHER RESOLVED, That this definition is not meant to supercede or replace
11 definitions of homelessness that have been set forth by funding sources, contractual
12 agreements, or existing data collection systems.




