10 WHEREAS, the San Francisco Public Library continually develops
11 the collection of library materials for use by patrons; and,

12 WHEREAS, The Friends and Foundation of the San Francisco Public
13 Library is a non-profit organization that seeks to provide
14 outstanding support for the Public Library by providing resources to
15 accomplish Library goals; and,

16 WHEREAS, The Public Library has requested, and the Friends and
17 Foundation of the San Francisco Public Library have agreed to fund
18 \$12,000 to purchase books, videotapes and other materials related to
19 the gay, lesbian, transgender and bisexual community; and,

20 WHEREAS, The Library proposes to maximize use of available gift
21 funds on materials by not including indirect costs in the gift
22 budget; now, therefore, be it

23 RESOLVED, That The San Francisco Public Library be authorized to
24 accept and expend a gift of \$12,000 from the Friends and Foundation
25 of the San Francisco Public Library to develop specified collections.




