13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 **RESOLVED**, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 47
20 on-sale general eating place liquor license and the exchange of said license to a Type
21 48 on-sale general public premises license to Isabel A. Manchester for WISH SF LLC
22 located at 1539 Folsom Street, District, 6, will serve the public convenience and
23 necessity of the people of the City and County of San Francisco.

24 Conditions: 1) Sales, service, or consumption of alcoholic beverages shall be
25 permitted only between the hours of 11:00 a.m. and 2:00 a.m. each day of the week.

1 2) The petitioner shall be responsible for maintaining free of litter the area in front of and
2 adjacent to the premises over which they have control. 3) The petitioner shall have a
3 doorperson on Thursday, Friday and Saturday nights between the hours of 7:00 p.m.
4 and 2:00 a.m.


