

1 [Authorizing the Department of Public Works to enter into a grant agreement with, and apply,  
2 accept and expend a grant of up to \$500,000 from the California Integrated Waste  
3 Management Board for clean-up of illegal dumping sites in San Francisco]

4 **Resolution authorizing the Director of Public Works to accept and expend a grant in**  
5 **the amount of \$500,000 from the California Integrated Waste Management Board for**  
6 **clean-up of illegal dumping sites in San Francisco.**

8 WHEREAS, the People of the State of California have enacted Assembly Bill 2136 that  
9 authorizes the California Integrated Waste Management Board (CIWMB) to initiate and  
10 administer a program for cleanup of solid waste disposal sites and for cleanup of solid waste  
11 at codisposal sites where the responsible party either cannot be identified or is unable or  
12 unwilling to pay for timely remediation, and where cleanup is needed to protect public health  
13 and safety or the environment; and

14 WHEREAS, the Department of Public Works (the Department) has identified more  
15 than 25 hot spots of illegal disposal within the City & County of San Francisco; and,

16 WHEREAS, the Department wishes to take measures to eliminate these illegal  
17 disposal hot spots with the assistance of grant funds from the CIWMB; and

18 WHEREAS, procedures established by the CIWMB require the grant application to  
19 certify by resolution the approval of said application; and

20 WHEREAS, the Department will enter into an agreement with the Board for the  
21 development of the projects as specified in the grant application; and

22 WHEREAS, Indirect costs are ineligible according to the CIWMB's rules and  
23 regulations; and,

1           WHEREAS, the City may choose to submit additional grant applications in future grant  
2 cycles for additional grant; now, therefore, be it

3           RESOLVED, That the Board of Supervisors does hereby authorize the Director of  
4 Public Works to enter into and execute a grant agreement with the Board; and be it further.

5           RESOLVED: That the Board of Supervisors hereby approves a grant application to be  
6 submitted to the CIWMB for an amount up to \$500,000 in FY 2001-02 for a Solid Waste  
7 Disposal Site Cleanup Program to eliminate and monitor 25 illegal dumping hot spots; and be  
8 it further


9           RESOLVED: That the Director of Public Works and his/her designee is hereby  
10 authorized and empowered to execute in the name of the City all necessary applications,  
11 contracts, payment requests, agreements and amendments hereto, for the purpose of  
12 securing grant funds and to implement and carry out the purposes specified in the grant  
13 application; and, be it further

14           RESOLVED: That the Director of Public Works and his/her designee is hereby  
15 authorized to apply for the same grant funds in future Fiscal Years, as the funds become  
16 available, for the same purpose. Future grant applications would be subject to all conditions  
17 of this resolution; and, be it further

18           RESOLVED: That the City waives indirect costs as they are not allowed by the grantor.






