4 **March 7, 2002 and designed to discuss the Continuum of Care plan with the goal of**
5 **coordinating the efforts from all community stakeholders to meet the goal of**
6 **eradicating homelessness in San Francisco.**

8 WHEREAS, San Francisco remains committed to the goal of eradicating
9 homelessness; and

10 WHEREAS, Supervisor Chris Daly and dozens of community leaders called for the San
11 Francisco Summit on Homelessness to raise awareness and understanding of the underlying
12 causes of homelessness; and

13 WHEREAS, Supervisors Tom Ammiano, Tony Hall, and Gavin Newsom have
14 introduced well-researched proposals at the Board of Supervisors to help address
15 homelessness; and

16 WHEREAS, The City's official policy—the Continuum of Care plan—involved the work
17 of hundreds of participants from all sectors of the community and non-profit organizations, the
18 goals of the Homeless Summit are to help coordinate their efforts in eradicating
19 homelessness; and,

20 WHEREAS, The goal of the Continuum of Care plan is to move toward a continuum of
21 integrated services that addresses the causes of homelessness in San Francisco; and,

22 WHEREAS, The outcome of the San Francisco Summit on Homelessness is to raise
23 public awareness by bringing all stakeholders to the table to discuss the Continuum of Care
24 plan and generate an ongoing, productive dialogue on ending homelessness; now, therefore,
25 be it

1 RESOLVED, That the San Francisco Board of Supervisors supports the goals of the
2 Homeless Summit to be held March 7, 2002; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors directs the Clerk of the Board
4 to properly notice this meeting so that a quorum of members of the Board of Supervisors may
5 attend if they are interested in doing so.
