

1 [Accept and Expend State Grant - Spousal Abuser Prosecution Program – Nine West
2 Augmentation]

4 **Resolution authorizing the Department of the District Attorney of the City and County**
5 **of San Francisco to retroactively accept and expend a grant in the amount of \$16,684**
6 **from the California Department of Justice for a program entitled “ Nine West**
7 **Augmentation – Investigations, Warrants, and Trial preparation”.**

9 WHEREAS, The City and County of San Francisco desires to continue a certain project
10 designated the San Francisco Spousal Abuser Prosecution Program – Nine West
11 Augmentation to be funded in part from funds made available through the California
12 Department of Justice (hereafter “DOJ”); and,

13 WHEREAS, The terms of the grant prohibit inclusion of indirect costs in the grant
14 budget; now, therefore, be it

15 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of
16 the City and County of San Francisco to retroactively accept and expend funds from DOJ for
17 the purposes of clearing up the backlog of felony domestic violence cases; and be it

18 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
19 indirect costs in the grant budget; and be it

20 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of
21 the City and County of San Francisco the necessary Grant Award Agreements for domestic
22 violence prosecution purposes including any extensions, augmentations or amendments
23 thereof; and be it

24 FURTHER RESOLVED, That the District Attorney is authorized and empowered to
25 execute, deliver and perform, in the name of the City and County of San Francisco, all

1 applications, contracts, agreements, amendments and payment requests necessary for the
2 purpose of securing Spousal Abuser Prosecution Program - Nine West Augmentation grant
3 funds and to implement and carry out the purposes specified in the applicable grant
4 application; and be it

5 FURTHER RESOLVED, That any liability arising out of the performance of the Grant
6 Award Agreement, including civil court actions for damages, shall be the responsibility of the
7 grant recipient and the authorizing agency; and be it


8 FURTHER RESOLVED, That grant funds received hereunder shall not be used to






